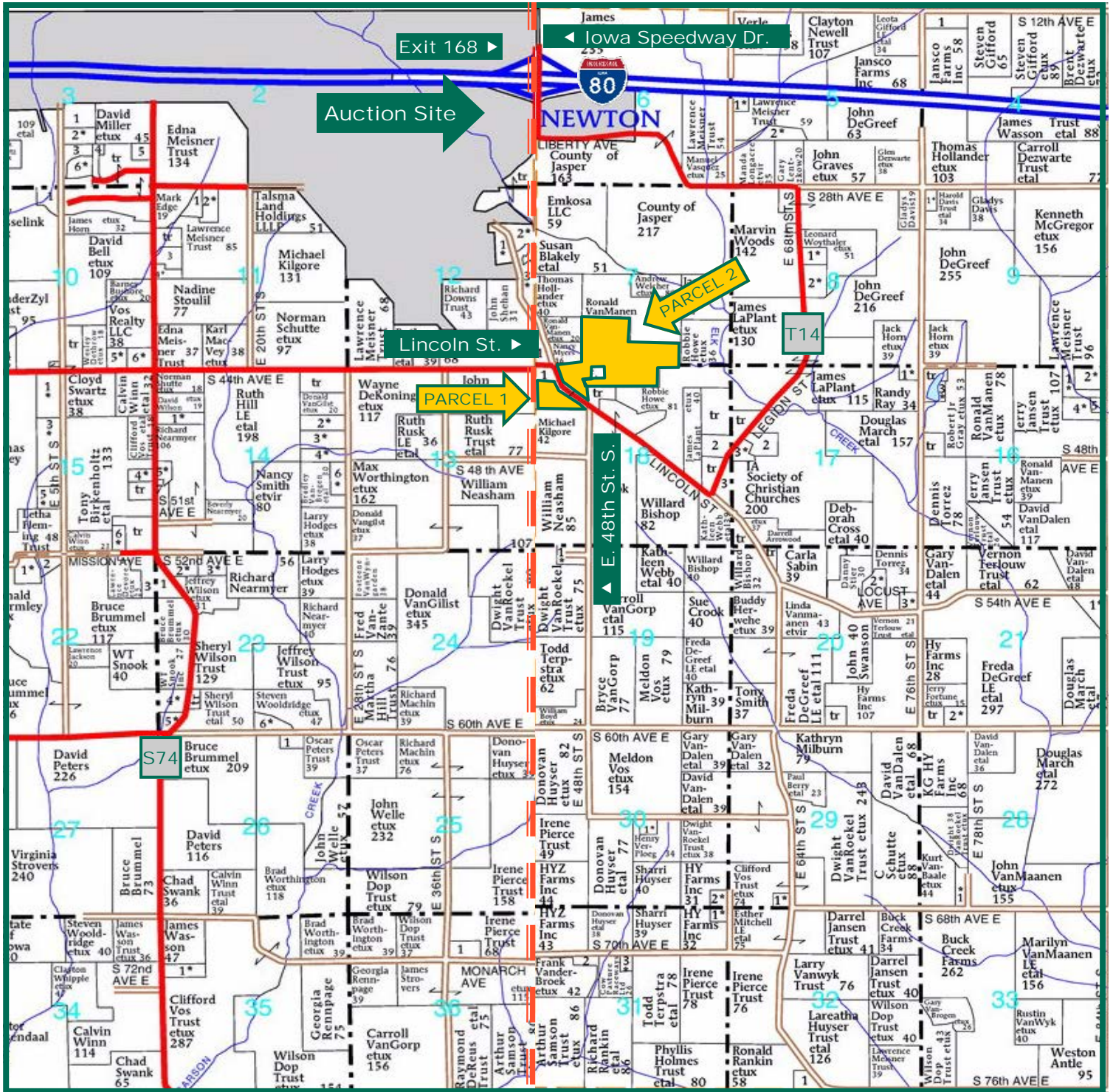
Possession will be given at settlement subject to the existing lease which expires February 28, 2017. Taxes will be prorated to November 30, 2016.
